OUR MISSION


Our Mission is to support healthcare services for Loudoun County residents who, as a result of economic or other barriers, would otherwise do without.

WHO WE SERVE

Loudoun Free Clinic serves adult Loudoun County residents who are uninsured and earn at or below 300% of the Federal Poverty Level. We are also a member-only clinic, so people apply and go through an eligibility process to become patients, and have to renew membership on a regular basis by providing tax returns and other documents.


